FINANCE COMMITTEE REPORT by Mike Reed

Mr. Reed noted that figures for year-to-date through October, 2010, are on pages 6 -9. Year-to-date figures through November, 2010, start on page 10. Total expenses through 11/2010 were \$1,472,405.06 giving us an operational surplus of \$72,497.77. We are under budget by \$244.21. The staff has been very careful with expenditures. Total Assets are \$10,815,023.58 and Total Liabilities are \$4,334,912.42. Our Mortgage Note is \$3,541,070.77, down from \$3,806,279.56 in 2010.

Total of Designated Funds is \$1,160,541.15 of which \$914,481.04 is the Building To Glorify Fund.
